| 1. Workers Compensation | Statutory limits |
| 2. Employers Liability | \$500,000 each accident
\$500,000 disease - policy limit
\$500,000 disease - each employee |
| 3. Commercial General Liability
Insuring against Bodily Injury,
Property Damage, Personal Injury,
and Advertising Injury | \$3,000,000 each occurrence
\$3,000,000 general aggregate
\$3,000,000 products/completed operations aggregate |

Any general aggregate shall apply on a “per project” basis for contractors. Coverage is to be provided on an “occurrence” rather than a “claims made” basis.

Note: An acceptable alternate is: \$1,000,000 primary coverage plus \$2,000,000 umbrella coverage

5. All insurance certificates should name as **additional insured**, as their interests may appear:

Ownership:	FSP Park Ten Phase II Limited Partnership FSP Property Management LLC, its asset manager
Property Manager:	Hines Interests Limited Partnership, the managing agent

6. All policies should have a 30-day cancellation notice.

8. ***NOTE: Any contractors whose work or services are considered “High Risk”** are required to provide a combined single limit of \$5,000,000 per occurrence, a general aggregate limit of \$5,000,000 and a products/completed operations aggregate of \$5,000,000. All other requirements remain unchanged. Umbrella excess liability, on an occurrence basis, that applies excess of required commercial general liability, business auto liability, and employer’s liability policies, which insures against bodily injury, property damage, personal injury and advertising injury claims with the following limits:***
